- (b) The Name of the District: Grand County Water and Sanitation District No. 1
- (c) The Powers of Grand County Water and Sanitation District No. 1 as authorized by 32-1-1004 and its Statement of Purpose:
 - 1. The purpose of the District as stated in the Statement of Purposes:

"The purpose of the District is to provide a complete water supply, storage and distribution system and, at a later date, a sanitary sewer system for the District and its inhabitants. A general description of the improvements to be constructed and installed within and for the District is:

- (a) A complete water system consisting of water storage tanks, mains and laterals and all necessary incidentals and appurtenances, and
- (b) A sanitary sewer system consisting of mains and laterals, and all necessary incidentals and appurtenances."

Both water and sanitation sewer systems have been constructed.

- 2. The District is not a metropolitan District as defined in 32-1-1004, but its general powers as a water and sanitation district are found under C.R.S. 32-1-1001, as well as C.R.S. 32-1-1006, as well as Financial Powers under C.R.S. 32-1-1101 and is generally governed by the provisions of C.R.S. 32-1-101, et. seq., and other Colorado statutory provisions.
- (d) The District Statement of Purpose can be amended from time to time, and which Statement of Purpose includes a description of the District's Powers and Authority and that a copy of the Statement of Purposes is available from the Division of Local Affairs of the State of Colorado.

GRAND COUNTY WATER AND SANITATION NO. 1 IS AUTHORIZED BY (e) TITLE 32 OF THE COLORADO REVISED STATUTES TO USE A NUMBER OF METHODS TO RAISE REVENUES FOR CAPITAL NEEDS AND GENERAL OPERATIONS COSTS. THESE METHODS, SUBJECT TO THE LIMITATIONS IMPOSED BY SECION 20 OF ARTICLE X OF THE COLORADO CONSTITUTION, INCLUDE ISSUING DEBT, LEVYING TAXES, AND IMPOSING FEES AND CHARGES. INFORMATION CONCERNING DIRECTORS, MANAGEMENT, MEETINGS, ELECTIONS. AND CURENT TAXES ARE PROVIDED ANNUALLY IN THE NOTICE TO ELECTORS DESCRIBED IN SECTION 32-1-809 (1), COLORADO REVISED STATUTES, WHICH CAN BE FOUND AT THE DISTRICT OFFICE, ON THE DISTRICT'S WEB SITE, ON FILE AT THE DIVISION OF LOCAL GOVERNMENT IN THE STATE DEPARTMENT OF LOCAL AFFAIRS, OR ON FILE AT THE OFFICE OF THE CLERK AND RECORDER OF EACH COUNTY IN WHICH THE SPECIAL DISTRICT IS LOCATED.
