# TOWN OF WINTER PARK, CO March 2022



### SALES, LODGING, ACCOMMODATION AND TRANSIT/TRAILS TAX REPORT

The Town of Winter Park Sales, Lodging, Accommodation, and Trails/Transit Tax Report examines tax collections for the month of March 2022, which were remitted to the Town in April 2022, and includes an analysis for the year-to-date results along with prior year results.

#### SUMMARY RESULTS FOR SALES, LODGING, ACCOMMODATION AND TRANSIT/TRAILS TAX

The Town of Winter Park's March 2022 sales tax collections were 54% above March 2021 collections. All Sectors are still experiencing double digit growth over 2021 collections year to date. The Restaurant & Bar Old Town Ski Area Sector had the most significant growth at 136% compared to March 2021. This is a reflection of the resort area having more restaurants & bars open as COVID restrictions lessen. The Lodging Sector also had a significant increase of 60% compared to March 2021. We attribute this to strong visitorship coupled with increased sales tax compliance now that booking platforms are required to remit sales tax directly to the Town for all bookings made through their sites. The Town's year to date collections exceed budgeted collections.












#### **2021 YTD TAX COLLECTION BY GEOGRAPHIC AREA**




# SALES, LODGING & TRANSIT/TRAILS TAX COLLECTION BY MONTH TOTAL COLLECTED




### SALES, LODGING & TRANSIT/TRAILS TAX COLLECTION DOWNTOWN




# SALES, LODGING & TRANSIT/TRAILS TAX COLLECTION OLD TOWN/SKI AREA





