TOWN OF WINTER PARK, CO March 2023 SALES, LODGING, ACCOMMODATION AND TRANSIT/TRAILS TAX REPORT



The Town of Winter Park Sales, Lodging, Accommodation, and Trails/Transit Tax Report examines tax collections for the month of March 2023 remitted to the Town in April 2023, and includes an analysis for the year-to-date results along with prior year results.

SUMMARY RESULTS FOR SALES, LODGING, ACCOMMODATION AND TRANSIT/TRAILS TAX

The Town of Winter Park's March 2023 sales tax collections were 2% above March 2022 collections. The Restaurant & Bar Old Town Ski Area location increased 15% compared to March 2022. The Lodging Sector had a slight decrease in collections compared to March 2022, but holds a 10% increase year-to- date. All other sectors remain higher compared to March 2022. The Town's year-to-date collections continue to exceed budgeted collections.







2023 YTD TAX COLLECTION BY GEOGRAPHIC AREA




2022 YTD TAX COLLECTION BY GEOGRAPHIC AREA




SALES, LODGING & TRANSIT/TRAILS TAX COLLECTION BY MONTH TOTAL COLLECTED

SALES, LODGING & TRANSIT/TRAILS TAX COLLECTION OLD TOWN/SKI AREA








